Sir,

With reference to your application on the subject cited above, I am directed to grant recognition to your school from class Ist to VIII (without aid) w.e.f. 1986-87 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act & Rules, 1973 framed thereunder as well as the instructions issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed and preference shall be given to the students of Pitampura.
3. That the school shall appoint full time qualified and eligible staff for all the classes of the school as per the present norms of the Department.
4. That the school shall equip the Science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students.
5. That a proper library shall be established and facilities for reading-room shall also be made available for students as well as teachers. Books as per the ratio of 10 books per student may be added and facilities of reading room may also be provided immediately and more books worth Rs. 4000/- may be purchased by the start of next session.
6. That adequate sports materials shall be purchased and made available to the students immediately. More sports materials worth Rs. 2000/- shall be purchased.
7. That the school shall comply with the provisions of Section 10 of Delhi School Education Act & Rules, 1973.

8. That the enrolment in each section shall not exceed the number of students calculated @ 12 Sq. ft. per student for the available floor area of the class-room and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class. Number of the existing sections should not exceed the number of the class rooms of proper size in the school.
9. That the school shall not run any pre-primary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. Nursery classes be removed from the premises of the school, if any. No branch of this school shall be run under the banner of the recognised school.
10. That the school shall dispense with the services of unqualified and over-daged staff, if any, immediately.
11. That service contract between the management and the employees shall be executed immediately.
12. That all the facilities prescribed under Rules 50 and 51 of the DSEB, 1973 shall be made available to the students. Provisions of Rules 6, 7 & 9 be strictly observed.
13. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health certificate may be obtained from the local body within a month.
14. That the management of the school shall create a Reserve Fund of Rs. 5000/- (Rupees five thousand only) in a joint account in the name of the Director of Education and the Manager of the school in any scheduled Bank within a month.
15. That the violation of any instructions/orders/conditions/rules and regulations of the department shall lead to the withdrawal of recognition of the school.
16. That the school society shall apply for the allotment of land and will construct the building as per the specifications.

Sir:

With reference to your application on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi for the upgradation of the existing secondary school to senior secondary level with effect from 1991-1992, session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of Delhi School Education Act and Rules 1973, as well as the instructions issued from time to time.
2. That the school shall admit the students without any discrimination of caste and creed.
3. That the school will meet the additional liability of senior secondary classes by appointing more staff as per the norms of the department and subjectwise PGTs shall be appointed and Govt. nominee shall also be invited at the time of the selection of the Teachers.
4. That the school shall establish and equip all the three separate science Labs. as per the norms of the Deptt. of CBSE. Separate Lab. Assistant for each Lab shall also be appointed.
5. That the proper Library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books available as per the ratio of 10 books per student and more approved standard books for senior classes and reference books for teachers shall be added by July, 1991 and a qualified librarian be appointed.
6. That more sport material for out-door games shall be purchased and made available to the students immediately during 1991-1992.
7. That the school shall strictly abide by the provisions of Section 10(i) of the Delhi School Education Act 1973, and payment shall be made through crossed cheque. Bonus, LTC, medical allowance, gratuity and pension as applicable to Govt. Employees of Delhi Admn. shall be paid to the employees of the school.
8. That the enrolment of each section shall not exceed the number of students calculated @ 12 sq ft per student for the available floor area of the class room and the school shall provide adequate

and sufficient accommodation as per the norms of the Directorate of Education in each class. Number of sections should not exceed the number of existing class rooms of proper size in the school and each class room, science labs., and library rooms may be fitted with proper electrical appliances.

9. That the school shall not run unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place at the above address only. Nursery classes if any, be removed from the premises of the school immediately.

10. That the school shall recruit the Teachers and other employees as per recruitment rules framed under DSER 1973. Services of unqualified and over-aged staff, if any, shall be dispensed with immediate effect.

11. That all the facilities prescribed under Rule 50 and 51 of the Delhi School Education Rules, 1973 shall be made available to the students.

12. That the arrangement for good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately. Health certificate may be obtained from the Local Body within a month.

13. That the violation of any instructions/orders/conditions/rules and regulations of the Department shall lead to the withdrawal of recognition of the school.

14. That the school building shall be constructed within a period of two years.
